

## PCI DSS 3.1: CERTIFICATE OF VALIDATION - August 12, 2015

Dara Security is pleased to provide this Certificate of Validation regarding the PCI Assessment and Accreditation for **Upshot Commerce**, a **Level 1 Service Provider located at <u>262 Essex St #2 Salem MA 01970</u> with data centers provided by Amazon Web Services and SoftLayer. Based upon the validation effort, <b>Dara Security** has determined that Upshot Commerce is <u>COMPLIANT</u> with the PCI DSS 3.1 in regards to their Upshot Commerce Platform.

Documentation review, preliminary interviews, and technical & physical inspections were completed in July 2014. Dara Security, a certified QSA, conducted this audit pursuant to PCI DSS v3.1 requirements, standards and guidelines and in accordance with PCI DSS Security Audit Procedures v3.1 and generated the PCI DSS Report of Compliance on August 12, 2015.

The scope of the assessment included all components of Upshot Commerce's infrastructure, applications, systems, Internet access points and processing connections that are involved in the processing, transmitting and/or storing of payment card data in regards to the Upshot Commerce Platform. Review areas included: Policy and Procedures; Data Flow Analysis; System Inventory and Documentation; Physical/ Environmental Security; Personnel and IT Staff Training and Awareness; Internal Vulnerability Assessment; Host/Network Diagnostic; Access Control; Data Storage; Wireless Network Analysis; Testing of Deployed Security Measures; and Monitoring/Response Assessment.

Dara Security reviewed results of Upshot Commerce's most recent quarterly scans, completed by a certified ASV vendor (SecurityMetrics) to confirm they covered all externally accessible (Internet-facing) IP addresses within the scope of the PCI DSS review and that the results of these scans were passing. Reviews of these security scans indicate that Upshot Commerce is compliant with the PCI ASV Scan validation requirements.

All requirements in the Report on Compliance are marked "in place", thereby Upshot Commerce has demonstrated full compliance with the PCI Data Security Standard v3.1.

A summary of Upshot Commerce's overall compliance with PCI DSS v3.1 guidelines and requirements is provided in the table below:
